2. Supervising the Board of Management by BODs

In the first 6 months of 2025, the Company continued to face many difficulties and challenges as the world and regional economic situation continued to be complicated and unpredictable, the USD/VND exchange rate and gold prices increased sharply; crude oil prices, materials prices, and freight rates fluctuated strongly; the domestic oil and gas sector has not shown any signs of improvement. In the above challenging conditions, in order to maintain and promote the production and business, BODs of the Company



strengthened regular and timely supervision and directed the Board of Management activities in accordance with its functions and authority, in accordance with the provisions of the Law and the Company's Charter, specifically as follows:

- BODs regularly monitored the activities of the Board of management and the Company's management staff through BODs direct meetings, monthly briefing of the Company, of BODs and reports (Financial statement, Business and production reports).
- BODs of the Company focused on monitoring and inspecting the plans preparation and approval procedures, on organization of production and business activities, and implementation of Resolutions of the General Meeting of Shareholders, Resolutions and Decisions of BODs.
- In addition, to intensify effectiveness of support tools for supervision activities, BODs resolutely directed the review and development of a system of bill of material and regulations in accordance with State regulations, practices on business management and corporate governance and the Company's production and business situation. Developed an action plan to implement key tasks in 2025 and disseminated it to all departments, officers and workers; mobilized all resources for production and business development.


4. Resolutions/Decisions of the Board of Directors:
